TEACHING

Student Success in Higher Education • EDL 6306 • Spring 2016, Summer 2019, Summer 2020, Summer 2021, Summer 2022

- This course examines the impact college has on students (college-impact models), as well as policies, programs, and practices that promote student learning and development in higher education. Theories concerning college student retention, engagement, achievement, and learning will be examined. Course topics include

several sets of variables (including student, organizational, and environmental characteristics) presumed to influence student success.

- This course provides an overview of the organizational structures and dynamics of higher education governance, leadership, planning, and resource allocation. Particular attention is given to the diversity of post-secondary institutions in the United States and how varying institutional settings influence organizational behavior, structures, and cultural norms of operating.

Person-Environment Theories • EDL 5373 • Summer 2011

- This course offers an in-depth analysis of person-environment theories, including the history and current use of such theories in higher education and student affairs. How people learn and the design of effective learning experiences and environments is also examined.

Planning, Budgeting, and Human Resources in Higher Education • EDL 5394 • Spring 2010, Spring 2011

- This course explores the interdependent relationship of university strategy formation, strategic planning, finance, and assessment. First, attention is given to theory-based

literature from both business and higher education as it relates to strategy formation and planning. Second, financial issues related to college and university administration are examined, including the nature of costs, their impact on students, and the future of higher education. Finally, the course explores the importance of assessment, its relationship to planning and finance, and how a higher education administrator can enact processes that inform desired outcomes.

Professional Seminar in Higher Education and Student Affairs • EDL 5100 • Summer 2015, Summer 2016, Summer 2017, Summer 2018, Summer 2019, Summer 2020, Summer 2021, Summer 2022

- This course is designed to orient higher education and student affairs graduate students to the profession, including topics such as writing, critical reading, critical thinking, and apprenticeship success.

Leadership in Higher Education and Student Affairs • EDL 5194 • Summer 2010

- This course is designed to encourage higher education and student affairs professionals to consider ways in which leadership contributions are made in the context of higher education.

Student Affairs Administration in Higher Education • EDL 5389 • Fall 2009

- This course explores the history of higher education and student affairs through an introduction to the various fields, organizations, and functions in college administration including trends, issues, and ethics.

Advanced Leadership • LDS 4398 • Spring 2012, Spring 2014

- This course provides insights into advanced leadership theory and how to use such theory to lead organizational and societal change efforts.

Talent & Development • LDS 3310 • Spring 2015, Spring 2017

- This course examines the science, theory, and research behind talent, development, success, critical thinking, and expertise.

Introduction to Leadership • LDS 1301 • Fall 2009

- This course provides insights into a student's present leadership strengths and developmental needs. Prepares students for leadership positions, focusing on topics such as a philosophy of leadership, the role of power and authority in leadership, and goal setting for leadership development.

Servant Leadership • CCS 1100 • Spring 2009, Spring 2010

- This course focuses on volunteerism and community service as related to poverty, literacy, local political participation, mentoring, peer education, community law enforcement, gender, and neighborhood development.

Leadership Development Seminar • LDS 1101 • Fall 2005, Spring 2006, Fall 2006, Fall 2007, Spring 2008, Fall 2008

- This course provides an overview of leadership theory and how such theory pertains

to college students.
